



Membership evolution


1. Initially, membership was free and included by default

2. 2022

- Membership became optional
- Fee based on company revenue

3. 2023

• Membership collected by non-profit (Qonto)




- Medium 1 to 10
- Large >10 M€



2022 members profile?

133 / 520 (25%) customers are members

- 75% are French, 14% in UE, 11% in rest of the world
- 67% are Large organizations, 22% Medium, 11% Small





Key takeaways

- France-IX non-profit board has up until now been focused on operational & tactical oversight.
 - While necessary in the early days, France IX Services is now mature
- Low member rates are a signal
 - Low value behind membership fees beyond vote
 - Unaddressed appetite for community building

In 2023+ France-IX non-profit board will go back and focus on its members



Evolution of governance 1/2

At inception: non-profit and private company's board were 100% overlapping, simplest approach for bootstrapping/expediency

- As the Private Company grows, need to streamline the way its board operates
- The non-profit mandate needs to outgrow its "unique shareholder of the private company" role
 - Potential legal and fiscal reclassification
 - Only a subset of customers are members
 - Members need value add, beyond voting right



Evolution of governance 2/2


Proposal

- Separate boards: Non-Profit, Private Company
 - Non-profit board members get representation in the Private Company board
 - Evolution of articles of association to update missions \rightarrow extraordinary meeting
- Non-Profit board primarily focuses on Members, For-Profit on Strategy & Execution
 - Non-Profit board members still elected via GM
 - For-Profit board members nominated (upon non-profit validation)
- Non-Profit clearly articulate, plan and announce value added proposition to members
- Capital opened to some France-IX staff for retention and comp competitiveness
 - Non-profit still holds majority stake (90%)



Customer survey

- 500+ customers (members or not) surveyed in March 2023
- 52 answers (only 10%)
 - 75% from French organization
 - 67% from technical people





Survey results

Noteworthy results:

- Membership status: members (51%), former member (19%), don't know (16%)
- Expectations: develop community (44%), France-IX services strategy (37%)
- 80% think important that company be owned by a nonprofit organization
- Capital opening to employee (64% Yes), to members (36% Yes)
- Communication: 66% interested by IM-like channels to exchange on technical discussions (19%), network incidents (17%), France-IX services (15%)
- Events (57% in region, 43% in Paris): Beer event (37%), conferences (37%)
- Role of representation of members interest in France: Yes 41%
- Role to support opensource tools (30%), small IXP (25%), training (21%)



Moving forward

The non-profit will support **general interest activities on Internet peering & network interconnexion** specifically for our community.

To achieve this, we will work on several axis:

- 1. Follow France IX Services development as shareholder
- 2. Animate France IX community
 - Communication, events with priority to members, exclusive events, strategic workshop with France IX Services team
- 3. Support French initiatives linked to our object
 - Small French IXP, network startup, network opensource tools,
- 4. Partnering with existing association / organization at French & European level
- 5. Decode the future of French internet & network interconnexion
 - Cloud access, Edge computing, TV, 5G, Online gaming, security, compliance
- 6. And more to build together (innovation, ...)

Next steps

- Extraordinary General Meeting in 2 months (Remote)
- 2023 members to vote on 2 topics:
 - 1. New status for the non-profit
 - 2. Capital opening to France-IX staff
