



1.1 REVIEW OF THE YEAR 2022 BY Franck Simon, France-IX President

The year 2022 marked an important step in France-IX's development. Indeed, after a year 2021 marked by the merger with Rezopole, in 2022, we initiated a project to develop the Lyon metropolitan infrastructure, both in terms of renewing the fibre infrastructure and a longer-term project to renew all the equipment. The aim is to have a strong Paris-Lyon-Marseille axis, homogenous in terms of transport capacity, but also to harmonise all services within the perimeter. We have activated redundant 100 Gbps links between these 3 cities to enable access to our peering services, regardless of the connection site. We also decided to expand into Toulouse, by taking over from ToulX, and migrating all the members present on our infrastructure.




Let's also note that the model we recently migrated towards - i.e., separating ports from services, with high-speed ports at very accessible prices and then charging for services subscribed to/ activated on these ports - has made a major contribution to positioning the 100 Gbps client port as the new standard. This has also led us, particularly on the Paris metropolitan network, to define n*400 Gbps transport capacity as the new standard for our infrastructure.




These developments, both in terms of new Points of Presence and infrastructure consolidation, have enabled us to welcome new customers and continue our sustained growth.


ANNUAL SERVICE AVAILABILITY





TOTAL NUMBER OF ROUTES ON RS




PEAK TRAFFIC (TBPS) IN 2022

The 2022 General Meeting was held in May 2023, at the Business Center Paris Trocadéro. More than 80 people joined the event, which provided an opportunity to review the year's news and highlights for France-IX in terms of development and global strategy.


VOTE RESULTS AND NEW BOARD MEMBERS

The number of voters at the 2022 General Meeting reached 44 participants out of 133 electors, representing a turnout of 33%, thereby achieving the 25% quorum.

At the end of the vote, the accounts for the financial year from 1 July 2021 to 31 December 2022 were approved (39 yes, 2 no, 3 abstentions).








The accounts are presented to the France-IX community each year at the General Meeting, where members have the opportunity to vote to approve them. France IX Services closed its accounts on the 31st of December 2022. The figures in this report relate to the period from the 1st of July 2021 to the 31st of December 2022. As the financial year is therefore 18 months, no comparison with previous years will be possible.

France-IX's turnover has continued to rise in 2022, with a significant growth rate of 18.54% compared with 2021, representing €1,067K.


OPERATING EXPENSES

The operating expenses represent more than €10,211K, offset by operating income of more than €10,753K. The largest items of expenditure were staff costs, leasing for the acquisition of the premises, rental space in data centres, and leasing of network equipment.



MANPOWER COSTS

The payroll tax expenses represent 48.61% of paid gross wages. Total salary costs grew by 8.77%, while the number of employees has increased by 12.50%. In 2022, France-IX reached a total of 36 employees.



CASH-FLOW & NET RESULT

On the 31st of December 2022, the treasury stands at €1,500K (for 18 months), compared with €1,683K (for 12 months) in the previous financial year. This significant reduction is due in particular to increased investment in our technical infrastructure.

The net result for the accounting period from the 1st of July 2021 to the 31st of December 2022 is €376K.
